TO: ALL PARENTS IN THE WEEKDAY EDUCATION MINISTRY

Each year, the Department of Pensions and Securities requires us to re-apply, for church exempt status. Lakeside Baptist Weekday Education desires to remain as a church-operated, non-licensed preschool program. Upon review of the requirements for licensing, we determined that Lakeside Baptist Weekday Education already meets the majority of the requirements which would permit a license. The Weekday Education Parent / Student Handbook answer most of the pertinent questions. In addition, appropriate certifications from the Health Department, Fire Department are kept on file in the office.

We believe licensing by the Department of Pensions and Securities would warrant additional governmental control. Believing strongly in the separation of church and state, our desire is to remain an unlicensed entity in order to direct our own activities without any government intervention. We believe, through our own requirements, that our program meets or exceeds those of any governmental agency.

The major requirement for operating a weekday education program without benefit of a license is that an affidavit must be signed by participants indicating they have been made aware that we choose not to be licensed. Your signature and return of this letter to the Lakeside Weekday Education Director will assure our compliance with this requirement.

We appreciate your assistance and cooperation in this matter. If you have questions or concerns please feel free to call. We appreciate the confidence you place in us by entrusting your children to us. The care of your children is a joy and blessing, and daily we seek to improve our care and our ministry to you.
